

GROUND HANDLING & AIRPORT FEES 2026

GENERAL INFORMATION

Payment

The fees listed in this price list (in SEK) shall be paid to Ängelholms Flygplats AB by the owner or user of the aircraft. Value added tax (VAT) shall be paid according to the law on value added tax. All prices are due for immediate payment.

Agreement can be made, depending on frequency, volumes and solvency, concerning invoicing with payment term of 30 days. Late payment will result in interest in overdue payments.

Standard Opening Hours

The Airports operational hours are established in AIP SWEDEN, AIP SUP and possible NOTAM. The standard opening hours correspond to domestic scheduled traffic.

During summer period, and major holidays, changes in opening hours are published in NOTAM.

Charter and New Destinations

Regarding pricing for charter periods and new destinations, tour operators or airlines should contact Airport Management. An incentive program is available for new destinations.

Exemptions

Due to international practice charges shall normally not be levied on foreign State aircraft used for the missions of foreign heads of state, members of government or similar official occasions.



PRICELIST GROUNDHANDLING

Ground handling includes loading/unloading of luggage, GPU (60 min), wheel chocks, luggage cart, marshal and crew transportation AC/Terminal. Performed according to IATA AHM.

The fee is per call - two movements, landing and the subsequent take-off, in 1 hour.

Extra Opening

The following additional charges outside of opening hours are valid for landing and take off in direct connection to standard opening hours.

Wintertime Oct 15 - Apr 14

Summertime Apr 15 - Oct 14

There is a minimum charge of 3 hours for landing and take-off if the extra opening hours are not in direct connection to standard opening hours.

Extra opening includes ATS, rescue and fire fighting services, and runway maintenance (wintertime; snow ploughs, blowers, sweepers, spreaders).

Cancellation of Extra Opening that are not announced to Ängelholms Flygplats AB at least 24 hours before arrival/departure will be charged FULL fee.



PRICELIST AVIATION

Passenger Fee – Commercial Flights

Per departing passenger, domestic (international)

148 (148) SEK

Exemptions from passenger charges are passengers in private flights, and infants under two years of age.

Take-off Fee 150 SEK/tonne MTOW (Minimum 250 SEK),
charter period/ new destination, see page 1.

The Airport is affiliated to Swedavias joint system of Annual Card.

A reduction of 50% for training flights arranged by commercial airline operators for the purpose of acquainting members of staff with new equipment and/or new types of aircraft and/or training provided that paying passengers or cargo are not carried.
